

Name The Course OFFICIAL RULES

1. The Name The Course contest (hereafter “Contest”) is organized by Predator Ridge Resort (“Predator Ridge”). It starts on August 10, 2009 and closes on September 24, 2009 at 11:59 pm (EDT). Any reference to time in this document indicates Pacific Daylight saving Time (PDT).

ELIGIBILITY

2. The Contest is governed by Canada law and is open to all residents of Canada excluding Quebec residents and who have reached the age of majority in the province in which they reside by the start date of this contest as identified above, with the exception of (i) the employees, agents and/or representatives of Predator Ridge, its distributors or affiliated companies, advertising agencies or any contributor to the Contest, as well as (ii) anyone with whom an employee, agent and/or representative of any of the above is domiciled or any member of his or her immediate family. For these official rules, “immediate family” refers to the father, mother, brothers, sisters, children, husband, wife or partner of such an employee, agent and/or representative.

 - 3.1 Log on to www.predatorridge.com/namethecourse and go to the “Entry Form” page. Complete the electronic entry form (hereafter the “Electronic Entry”) by filling all required fields. Click on “Submit”. You will then be entered in the Contest. You can enter the Contest until September 24, 2009 at 11:59 pm.
 - 3.2 Each entrant whose Electronic Entry will have been randomly selected will be contacted by Predator Ridge; before the fulfilment of the Prize and as essential condition to its fulfilment, such entrant will have to answer correctly a Mathematical question. Following a correct answer to the Mathematical question such entrant will be declared a winner (each such winner shall be hereafter collectively or individually referred to as “Winner” subject to every other condition stipulated in the present rules and regulations)
 - 3.3 Each entrant can only use one e-mail address (which must be valid) to enter via the Electronic Entry form. One (1) entrant per Electronic Entry form. One (1) Electronic Entry per day per person for the duration of the Contest. The same e-mail address cannot be used by more than one entrant.

DRAW

One Grand Prize will be drawn from all of the Entry Forms received on September 30, 2009 at 12:00 pm at the offices of Predator Ridge located at 301 Village Centre Place, Vernon, BC V1H 1T2 for the Prizes.

GENERAL TERMS AND CONDITIONS

7. To be declared a Winner, an entrant whose Entry Form is randomly chosen for the Prize must respect the entry and eligibility conditions stipulated in this document. Failure to respect one or several of these conditions means the Winner will be disqualified and another random draw will be conducted to choose another Winner.
8. Limit of one weekly Prize per person and one Grand Prize per person.
9. Predator Ridge will contact the Winners by telephone and/or e-mail. In the event that the Predator Ridge cannot contact the selected Winner of one or several of the draws for whatever reason within forty-eight (48) hours following the draw, Predator Ridge will conduct as many draws as necessary from the Entry Entries to find the appropriate number of Prize Winners.
