

'Predator Ridge Showhome Showcase'
OFFICIAL RULES

1. The 'Predator Ridge Showhome Showcase' contest (the "Contest") is organized by Predator Ridge Resort ("Predator Ridge"). The Contest begins on September 4, 2010 and closes on September 5, 2010 at 4:00 pm (PDT). Any reference to time in this document indicates Pacific Daylight saving Time (PDT).

ELIGIBILITY

2. The Contest is governed by the laws of the Province of British Columbia and Canada and is open to all residents of Canada (excluding Quebec) who have reached the age of majority in the province in which they reside by the start date of the Contest, with the exception of: (i) the employees, agents and/or representatives of Predator Ridge, its associated and affiliated companies, advertising agencies or any contributor to the Contest, as well as (ii) anyone with whom an employee, agent and/or representative of any of the above is domiciled or any member of his or her immediate family. HOW TO ENTER

 - 3.1 Obtain a contest ballot entry form (the "Ballot Form") from the Real-Estate Sales Centre located at 100 Mashie Crescent, Vernon, BC V1H 1V8, complete the Ballot Form by filling all required fields, and place the Ballot Form in the draw box prior to 4:00 pm on September 5, 2010 to be entered in the Contest.
 - 3.2 The entrant whose complete Ballot Form has been randomly selected (the "Selected Entrant") will be contacted by Predator Ridge. As a condition to the fulfilment of the Prize the Selected Entrant must correctly answer a mathematical skill testing question, and following verification of a correct answer the Selected Entrant will be declared a winner (each such winner shall be hereafter collectively or individually referred to as the "Winner", subject to every other condition stipulated in the present rules and regulations)
 - 3.3 Each entrant may only use one e-mail address and one phone number (which must be valid) to enter the Contest. Each entrant must only enter one (1) Ballot Form per day for the duration of the Contest. The same e-mail address may not be used by more than one entrant.

DRAW

6. At 12:00 pm noon on September 7, one (1) Ballot Form will be drawn at random from among all the Entry Forms receive in the ballot box at the Predator Ridge real estate sales centre located at 100 Mashie Crescent, Vernon, BC V1H 1V8.

GENERAL TERMS AND CONDITIONS

7. To be declared a Winner, the Selected Entrant must comply with the conditions stipulated in these Official Rules. Failure to comply with one or several of these conditions shall disqualify the Selected Entrant and another random draw will be conducted.
8. Limit of one Prize per person.
9. Predator Ridge will contact the Selected Entrant by telephone and/or e-mail. In the event that Predator Ridge is unable to contact the Selected Entrant for whatever reason within forty-eight (48) hours following the draw, Predator Ridge will conduct as many additional draws as may be necessary to determine a Winner.
